The Competition Commission, based on the results of consideration of the submitted bids , DECIDED:


1. to allow to participate in the Selection of potential suppliers:

3. To the Secretary of the Competition Commission to place this protocol on the Internet resource of the Company www.alaport.com after 3 (three) working days from the date of opening the bids.


